



## **THIRD PARTY MANAGEMENT AGREEMENT**

The Third-Party Agreement (“Agreement”) is made and effective as of the Between:

WHEREAS Customer desires to purchase/sell CFDs

WHEREAS Service Provider desires to provide Automated Trading Services to the Customer for a fee.

WHEREAS Customer desires to have Service Provider render Automated Trading Services on his/her trading portfolio.

WHEREAS the Service Provider has the technology and industry insight to provide Automated Trading.

In consideration of the terms of this agreement, and other valuable consideration, the parties agree as follows:

### **1. SCOPE OF AGREEMENT**

Service Provider will provide to the Customer the technology to facilitate Automatic Trades.

The Customer will allow the Service Provider to access his/her trading portfolio and to facilitate automated trades on behalf of the Customer.

### **2. TERM AND TERMINATION**

The term of this Agreement shall begin on the Effective Date and shall end after 14(Fourteen) days after written termination has been provided by either party.

### 3. EXCLUSIVITY

During the term of this Agreement, the Service Provider will have the exclusive right to provide Automated Trading Services to the Customer.

### 4. SERVICE PROVIDER FEES

For the Services offered by the Service Provider to the Customer. The Service Provider will charge a set fee of \$100 per month.

### 5. INDEPENDENT CONTRACTOR & LIABILITY

The Customer acknowledges that the Service Provider is offering the services contained herein as an Independent Service Provider.

The Customer indemnifies the Service Provider and/or any third parties from liability for any losses that may occur as a result of the services offered by the Service Provider.

### 6. ENTIRE AGREEMENT

The Parties hereto agree that this Agreement shall not become effective until accepted by both Parties and when accepted, shall supersede, and replace all previous Service Provider Agreements, whether oral or written, between the parties. The parties agree that this Agreement contains all the contractual arrangements existing between them relative to the Service Provider relationship, and all other written or oral arrangements are deemed to be merged herein.

### 7. GOVERNING LAWS

This Agreement shall be interpreted and enforced in accordance with the laws of the Saint Vincent and the Grenadines the courts of which state shall have exclusive jurisdiction over the parties as respects any dispute arising hereunder.
